# Faithful Friar's Report – Father Piskora

A lot of people think that there are some changes that should be made in Church Law and Tradition. A lot of people are hoping that Pope Francis is the one that will make these changes. There is one Church prohibition that it would like to see lifted as soon as possible. It is the Church rule that says people who are in an invalid marriage should not go to Communion. I think that this is a law that is no longer meaningful or relevant. In fact I think that is oppressive. It wasn't meant to be this way but that's the way it has become. The first thing we should remember is that it is Church legislation and not God's law. So there is no reason it can't be changed or modified. When the rule was first enacted it was meant to be a preventative and not punitive. It was meant to be just another factor that the Church felt would help people avoid the pitfall of divorce. It was meant to help married couples stay faithful to the marriage vows they had exchanged. Society was against divorce. People felt that the marriage bond should not be broken. Even civil law discouraged divorce. So the Church put this rule in effects just another reason to respect the idea that marriage is forever.

But so much has changed. No one ever imagined that divorce would become so prevalent. So something that was meant to be a source of prevention has now become more of a punitive legislation. It is now just one more hardship that people face when they enter another marriage after going through a divorce.

Changing the law does not mean the Church is changing it's attitude toward divorce, but the fact is that so many people have found themselves being denied the Eucharist. It's time for the Church to take another look at prohibition. Pope Francis has misgivings about it. There's got to be a better way to protect the sacred nature of the marriage bond. It is doing more harm than good.
